QUALITATIVE AND QUANTITATIVE COMPOSITION

Active Ingredient:

Each 5ml contains Hedera Helix L. folium (Ivy Leaf extract 6:1) 35mg

EXCIPIENTS:

Potassium Sorbate (1,00% v/m) as preservative
Sorbitol 70% (3g / 5ml)

PHARMACEUTICAL FORM

HEDERA HELIX COUGH SYRUP CHERRY MENTHOL: Naturally coloured light brown syrup with a sweet taste. Hedera Helix L extract is a natural extract therefore the colour may vary occasionally but this does not affect efficacy.

CLINICAL PARTICULARS

Therapeutic indications

HEDERA HELIX COUGH SYRUP is a Western Herbal Complementary Medicine product used as an expectorant in case of productive cough and helps with the release and elimination of mucus.

POSOLOGY AND METHOD OF ADMINISTRATION

SHAKE WELL BEFORE USE

Special populations

DOSAGE AND DIRECTIONS FOR USE

Adults and elderly:
5ml three times daily.

Children over 6 years and adolescents:
5ml three times daily.

CONTRAINDICATIONS

Hypersensitivity to the active substance, to plants of the Araliaceae family or to any of the excipients of HEDERA HELIX COUGH SYRUP.

Children under 6 years of age because of the general risk of aggravation of respiratory symptoms through secretolytic drugs.

SPECIAL WARNINGS AND PRECAUTIONS FOR USE

HEDERA HELIX COUGH SYRUP contains Sorbitol 70% and may have a laxative effect.

Patients with the rare hereditary condition of sorbitol intolerance should not take HEDERA HELIX COUGH SYRUP.

When shortness of breath, dyspnoea, fever or purulent sputum occurs, a doctor or pharmacist should be consulted.

Caution is recommended in patients with gastritis or gastric ulcers.

Interaction with other medicines and other forms of interaction

No interaction studies were performed.

Concomitant use with other expectorants such as a codeine or dextromethorphan without medical supervision is not recommended.

Fertility, pregnancy and lactation

The safety of HEDERA HELIX COUGH SYRUP during pregnancy and lactation has not been established.

NOT RECOMMENDED FOR USE DURING PREGNANCY OR LACTATION

Effects on ability to drive and use machines

HEDERA HELIX COUGH SYRUP has no effect on your ability to drive vehicles or operate machinery.

However, do take care if you take HEDERA HELIX COUGH SYRUP until you know how it will affect you.

UNDESIRABLE EFFECTS

Frequency not known:

Gastrointestinal reactions - Nausea, vomiting, diarrhea.

Allergic reactions - Urticaria, skin rash, dyspnea, anaphylactic reaction.
